In the event that any exercise date does not fall on a business day of the Company, the exercise date will be the business day preceding such date, with the exception of the last exercise date for which the warrant holders shall notify their intention to exercise the TFG-W2 Warrants within the period of no less than 15 business days prior to the last exercise date.
Irrevocability of the notice of intention to exercise the Warrants	The intention to exercise the TFG-W2 Warrants may not be revoked when a notice of intention to exercise the TFG-W2 Warrants is served.
Conditions for the adjustment of rights	The Company will adjust the exercise price and/or the exercise ratio pursuant to the conditions for the rights-adjustment upon the occurrence of any of the events stipulated in the terms and conditions of the TFG-W2 Warrants as prescribed in Clause 11(4)(b) of the Notification of the Capital Market Supervisory Board No. TorChor. 34/2551 Re: Application for and Approval of Offer for Sale of Newly Issued Share Warrants and Newly Issued Underlying Shares such as:

- (a) the change in the par value of the company's shares as a result of a combination or a splitting of shares;
- (b) the company's offer for sale of newly issued shares at a price below market price;
- (c) the company's offer for sale of convertible debentures or warrants at a price below market price;
- (d) the company's payment of dividend to shareholders, either wholly or partially, in the form of newly issued shares;
- (e) the company's payment of dividend in an amount exceeding the figure specified in the terms and conditions of warrants; and
- (f) any other events of similar nature to the events in (a) to (e) rendering that any benefits the warrant holders are entitled to, upon the exercise of the TFG-W2 Warrants, will be prejudiced.

In this regard, the Executive Committee or a person delegated by the Executive Committee shall be authorized to determine amend and revise the other conditions and details in connection with the adjustment or change of the exercise ratio and exercise price.

Other conditions

The Executive Committee or a person authorized by the Executive Committee shall be authorized to amend the date to record the names of the shareholders who are entitled to purchase the TFG-W2 Warrants proportionate to their respective shareholding (Record Date) and the date to list the names of the shareholders in compliance with Section 225 of the Securities and Exchange Act B.E. 2535 (1992) (including any amendment thereto), as deemed appropriate by taking into account the benefits of and impact upon the Company;

and to determine the rules, conditions, and other details of the TFG-W2 Warrants, and to allocate, enter into negotiation and agreements, and execute the relevant documents and agreements, as well as to undertake any act necessary for and relevant to the issuance and allocation of the TFG-W2 Warrants, including to list the warrants and the ordinary shares issued as a result of the exercise of warrants on the Stock Exchange of Thailand, and to apply for permission from the relevant government agencies.

Effects on the shareholders

- 1. The ordinary shares issued from this exercise of the TFG-W2 Warrants will have the same rights and conditions as those which have been issued by the Company, in all respects;
- 2. Apart from 510,866,470 ordinary shares (at the par value of Baht 1 per share) which are reserved to accommodate the exercise of the TFG-W2 Warrants, the Company may be required to further increase its capital in order to accommodate the rights-adjustment of Warrants to Purchase Newly-Issued Ordinary Shares No.1 (TFG-W1) or in the case of events under the notifications of the Capital Market Supervisory Board in relation to the issuance and offering of warrants; and
- 3. The effects on the shareholders shall be considered based on the assumptions
 - 3.1 the effects on the shareholders to be considered by excluding the unpaid capital in two cases as follows:

Case 1: The existing shareholders exercise the rights to purchase

all ordinary shares.

Case 2: Other persons not being shareholders exercise the rights to purchase all ordinary shares (the existing shareholders sell all of their warrants on the Stock Exchange of Thailand).

1. Control Dilution

Case 1: Control Dilution is equivalent to zero

Case 2: The effects of Control Dilution on the shareholders are as follows:

Calculation formula:

- Qo = Number of the existing ordinary shares which is equivalent to 5,108,664,700 shares as at 23 February 2017, which is the date on which the Board of Directors' Meeting resolved to approve the issuance and offering for sale of the TFG-W2 Warrants.
- Qw = Number of new ordinary shares increased after the exercise of all TFG-W2 Warrants, equivalent to 510,866,470 shares.

2. Price Dilution

- Po = Baht 6.48 per share, which is the weighted average price of the Company's ordinary shares traded during the period of 15 consecutive business days (from 1 February 2017 22 February 2017).
- Pn = (PoQo) + (Exercise price of TFG-W2 x Qw) / (Qo+Qw)
 - $= (6.48 \times 5,108,664,700) + (9.5 \times 510,866,470) / (5,108,664,700 + 510,866,470)$
 - = Baht 6.75 per share

Since Po < Pn, the issuance and offering for sale of the TFG-W1 Warrants does not, therefore, cause any price dilution.

3. Earnings per Share Dilution (EPS Dilution)

Calculation formula:

EPSo = Net profit / Qo = 1,446,801,000 / 5,108,664,700 = 0.2832
